"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Woodruff Road and having according to plat of the property of Rocky Creek Baptist Church recorded in Plat Book R, Page 177, the following metes and bounds:

BEGINNING at point in the center of the Woodruff Road and center of another road adjacent to the property of Rocky Creek Baptist Church and running thence with the center of said road S. 69-33 E. 163.9 feet to pin; thence S. 75-29 W. 109.7 feet to point in center of first mentioned county road; thence with the center of said road N. 2-56 W. 188 feet to the point of beginning.

Being the same premises upon which the church parsonage is located, same having been conveyed to the mortgagor by deed recorded in Deed Book 331, Page 433.
