, with interest thereon from date

at the rate of six per centum per annum, to be computed and paid quarterly

until paid in full; all interest not paid when due to bear

All that piece, parcel or lot of land near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 9 on a survey of property of Walter W. Goldsmith made by Madison H. Woodward, dated April 1946, and having, according to the survey, the following metes and bounds, to-wit:

BEGINNING at an iron pin on East Washington Street Extension (formerly Paine Street) at the joint front corner of Lots Nos. 3 and 9, and running thence along the line of said LotNo. 8, N. 33-52 E. 150 feet to an iron pin; thence S. 56-08 E. 50 feet to an iron pin at the back corner of Lot No. 10; thence along the line of said lot No. 10, S. 33-52 W. 150 feet to an iron pin on East Washington Street Extension (formerly Paine Street); thence with the said East Washington Street Extension (formerly Paine Street) N. 56-08 W. 50 feet to the iron pin, point of beginning.
