

SEND GREETING:

All that certain piece, parcel or tract of land lying and being in Gantt Township, Greenville County, State of South Carolina, being known and designated as lot No. 50 on a plat thereof of "Conestee, S. C." recorded in Plat Book K, at page 276, Greenville County RMC Office, and being the same lot conveyed to John Gresham by Frank J. Fowler by deed dated March 11, 1949, recorded in Deed Book 375 at page 386 and being likewise the same parcel of land conveyed by John Gresham to Albert and Dora Moore.
