W. T. Fowler and Anna T. Fowler (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

----Fifteen Thousand and No/100----  
DOLLARS (\$ 15,000.00 ), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid in monthly instalments of One Hundred Five and No/100----- Dollars (\$ 105.00 ) each on the first day of each month hereafter

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

lying on the northern side of Vicki Circle, being designated aslot # 15, on a plat of Cherokee Forest III, recorded in the RMC office for Greenville County in Plat Book QQ at Pages 36 and 37, and being more particularly described as follows:

BEGINNING at an iron pin on the northern side of Vicki Circle, at the joint front corner of lots # 14 and 15, and running thence with the line of lot # 14, N. 7-6 E. 203.7 feet to iron pin at the corner of lot # 16; thence with a branch and the line of lot # 16 S. 40-20 E. 130.1 feet to iron pin; thence continuing with said branch and said lot, S. 59-59 E. 80.5 feet to iron pin; thence continuing with said branch and line of said lot, S. 29-6 E. 87.5 feet to iron pin on the northern side of Vicki Circle; thence with the northern side of Vicki Circle, N. 85-29 W. 193.6 feet to iron pin; thence continuing with Vicki Circle, S. 87-47 W. 30.2 feet to the point of beginning.

Being the same premises conveyed to the mortgagors by G. E. Tripp and Robert W. Ramsey by deed to be recorded.
