(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Two THOUSAND and no/100

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Slater, S. C., known as lot No. 4 and a lot immediately to the rear thereof, in Block B of S. Slater & Sons Subdivision as shown on plat book K at page 63, and book DD at page 121, and having, according to said plats, the following metes and bounds, to-wit:

Beginning at an iron pin on Whitney Street at the corner of lot No. 3 and running thence N 2-27 W, 70 feet to an iron pin at the corner of lot No. 5; thence along the line of lot No. 5, N 87-34 E, 225 feet to an iron pin; thence S 2-27 E, 70 feet to an iron pin at the corner of lot No. 3; thence with said lot S 87-34 W, 100 feet to an iron pin, the point of beginning, and being a portion of that property conveyed to me in deed book 484 at page 305 and 246 at page 112. Both parcels of property were conveyed to Ina Belle Pittman who has subsequently married and is now Ina Belle Howard.
