in the City of Travelers Rest, on the Buncombe Road, designated as lot #.5, of the Love Estates Subdivision, as recorded in the RMC office for Greenville County in Plat Book !! at Pages 111 and 112, and according to said plat, having the following metes and bounds, to-wit:
