All that piece, parcel or lot of land situate, lying and being in Gantt Township, County of Greenville, State of South Carolina, on the Georgia Road, as shown on a plat of the property of Hazel Cureton and Lula Chapman by Jones and Sutherland, Engineers, dated March 21, 1960, and having according to said plat the following courses and distances, to-wit:

Beginning at a point (Bolt) in the center of the Georgia Road and running thence S 11-30 E 226.7 feet along the line of the Doris Mangum property to an iron pin; thence S 87-50 W 121.4 feet to an iron pin at joint back corner with the lot of Lula Chapman; thence N 7-08 W 210 feet along the line of the Lula Chapman lot to a point (Bolt) in the center of the Georgia Road; thence N 79-52 E 104 feet along the center of the Georgia Road to the point of beginning, containing 0.50 acres, more or less.
