**MORTGAGE**

STATE OF SOUTH CAROLINA  
COUNTY OF GREENVILLE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

C. RICHARD LAEMMEL AND BEVERLY S. LAEMMEL  
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Fifteen Thousand and No/100-----

DOLLARS (\$15,000.00), with interest thereon from date at the rate of Six (6%)----- per centum per annum, said principal and interest to be repaid in monthly installments of Dollars (\$) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

on the western side of Byrd Boulevard in the City of Greenville, being shown and designated as lot # 137, on a plat of Traxler Park, recorded in Plat Book F at Pages 114-115, and having according to said the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Byrd Boulevard at the joint front corner of lots # 137 and 138, and running thence with the line of lot # 138, S. 66-43 W. 324.2 feet to pin; thence S. 41-24 E. 73.64 feet to pin at rear corner of lot # 136; thence with the line of lot # 136, N. 66-43 E. 301.4 feet to pin on Byrd Boulevard; thence with the western side of said Byrd Boulevard, N. 29-17 W. 70 feet to the point of beginning.

Being the same premises conveyed to the mortgagors by Joe J. Faress by deed to be recorded.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
