(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Two Thousand Five Hundred and no/100

DOLLARS (\$ 2,500.00 ), with interest thereon from date at the rate of seven per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Highland Township, containing 1.5 acres, more or less, as shown on plat of property of Winford and Naomi P. Gosnell, recorded in the R. M. C. Office for Greenville County in plat book UU at page 139, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin in the center of a paved road, referred to as S. C. Highway #44, at the corner of property of Mrs. Wilson Roe, approximately 1,050 feet north of the intersection of Highway 101, sometimes referred to as the Tugaloo Road, and running thence along the center of said road the following courses and distances, the traverses of which are as follow: N 4-47 E, 26 feet to an iron pin; N 0-05 E, 100 feet to an iron pin; N 9-25 W, 100 feet to an iron pin; N 19-55 W, 100 feet to an iron pin; N 23-55 W, 100 feet to an iron pin; N 32-15 W, 100 feet to an iron pin at the corner of property of O. L. and Virginia H. Pace (there is an iron pin set back on the line 28 feet distance from the center of said road); and running thence along the Pace property S 46-15 W, 217.6 feet to an iron pin; thence along the property of Mrs. Wilson Roe, S 40-26 E, 455 feet to an iron pin at the point of beginning and being the same property conveyed to us by O. L. and Virginia H. Pace in deed book 663 at page 384.
