TO ALL WHOM THESE PRESENTS MAY CONCERN:

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Seventeen Hundred Fifty and No/100 DOLLARS (\$ 1750.00 ), with interest thereon from date at the rate of Six & One-Half per centum per annum, said principal and interest to be repaid in monthly instalments of Thirty-Four and No/100 Dollars (\$34.00 ) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

situate at the southwestern corner of the intersection of Easley Bridge Road and Beatrice Street, being shown and designated as lot 39 on a plat of Camilla Park # 1, recorded in Plat Book G at Page 225, and having according to said plat the following metes and bounds:

BEGINNING at a stake at the southwest corner of the intersection of Easley Bridge Road and Beatrice Street and running thence along the southern side of Easley Bridge Road, S. 56-33 W. 80 feet to a pin, corner of lot # 40; thence with the line of lot # 40, S. 53-30 E. 191 feet to a poin on an alley; thence with said alley, N. 55-58 E. 80 feet to a pin on Beatrice Street; thence with the western side of Beatrice Street, N. 33-30 W. 190 feet to the point of beginning.
