NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the southwesterly side of Lancaster Lane, near the City of Greenville, S. C., being shown as Lot 281-A on the plat of Belle Meade, Section III, as recorded in the RMC Office for Greenville County, S. C. in Plat Book GG, page 187, said lot fronting 85 feet on the southwesterly side of Lancaster Lane and having a depth of 158.2 feet on the southeasterly side, a depth of 168.9 feet on the northwesterly side, and being 47 feet across the rear.
