All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Southwestern side of White Horse Road, Greenville Township, Greenville County, State of South Carolina, being known and designated as the Southerly one-half of Lot No. 3 as shown on a plat of property of Thos. T. Goldsmith, prepared by W. J. Riddle, dated June, 1944, and recorded in the R. M. C.
