All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 5 on Mauldin Circle according to plat made for H. C. Taylor of December, 1956, and being more fully described in accordance with said plat, to-wit:
