NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and furthersums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Austin Township, on the Northemist side of Jones' Mill Road East of Simpsonville, and described as follows: BEGINNING at iron pin in the Jones' Mill road, thence North 0-45 East 209 feet to iron pin, thence South 89-15 East 170 feet to iron pin thence South 35-35 West  $65\frac{1}{2}$  feet to iron pin, thence South 0-45 West  $155\frac{1}{2}$  feet to iron pin in said road, thence North 89-15 West 209 feet to the beginning.
