Due and payable \$50.00 on the 5th day of each and every month hereafter, commencing April 5, 1961; payments to be applied first to interest, balance to principal, with the privilege to anticipate payment at any time,

with interest from date at the rate of six (6%) per centum per annum until paid; interest to be computed and paid monthly annually, and if unpaid when due to bear interest at same rate as principal until paid, and I have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said Inez M. Taylor,

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

R. H. Whitaker, Jr., his Heirs and Assigns forever:

all that tract or lot of land in

Township, Greenville County, State of South Carolina,

An undivided one-half (1/2) interest in and to:

All that piece, parcel or tract of land, situate, lying and being in Butler Township, Greenville County, State of South Carolina, and being shown as the property lying East of Miller Road on the Plat of Property of Myrtle J. McCarter Estate prepared by J. Mac Richardson dated April 16, 1954, which plat is recorded in the R. M. C. Office for Greenville County in Plat Book "TT" at Page 179 and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at a nail in cap in the center line of Miller Road in line of property heretofore conveyed to Truman Garnett and running thence along the center line of said Road, S. 6-54 E. 265 feet; S. 7-11 E. 260.5 feet; S. 6-04 W. 245.1 feet to a nail in cap in center line of said Road; thence N. 54-34 E. 314.4 feet to an iron pin; thence S. 39-15 E. 386.4 feet to an iron pin; thence N. 72-00 E. 475 feet to a hickory; thence S. 74 E. 204.4 feet to an iron pin; thence S. 83-30 E. 252 feet to an iron pin; thence S. 47 E. 237.6 feet to an iron pin; thence S. 61-30 E. 136.6 feet to an iron pin; thence N. 82 E. 370.2 feet to an iron pin at stone; thence N. 6-25 E. 1148.9 feet to an iron pin at stone; thence S. 84-40 W. 2084.5 feet to a stone; thence N. 70-09 W. 148.7 feet to a nail in cap in center line of Miller Road, the point of beginning, and containing approximately 43.7 acres.
