All that certain parcel or lot of land situated on the north side of Clark Avenue and the east side of Wood Drive, about one mile southward from the City of Greer, Chick Springs Township, Greenville County, State of South Carolina, and being all of Lot No. 61 and one-half of Lot No. 60 adjoining in Brookhaven, and being particularly designated and shown as the Property of Channing B.
