All that certain piece or percel of land in the Lake Lanier Subdivision, Glassy Countain Township, Greenville County, S.C., lying, being and situate on the Eastside of West Lake Shore Driverand being more perficularly described as follows:

Reginning at an iron pin on the Eastside of West Lake Shore Drive (said iron pin bearing S. 34-20 E. 30 feet from an iron pin at the front corner between lots 1171 and 1172 in the Lake Lanier Subdivision) and running thence S. 50-40 E. 31.7 feet to an iron pin at the edge of the waters of Lake Lanier; thence S. 38-41 W. 25 feet along the edge of the waters of Lake Lanier to an iron pin; running thence N. 42-04 W. 35.4 feet to an iron pin on the eastern edge of West Lake Shore Drive; thence along and with West Lake Shore Drive N. 48-59 E. 20 feet to an iron pin; being the point of beginning.
