GIACOMO BARONE and NANCY B. BARONE of Greenville, South Carolina, hereinafter called the Mortgagor, send (s) greetings;

Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released; and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

ALL that lot of land with the buildings and improvements thereon, situate on the West side of Azalea Court, near the City of Greenville, in Greenville County, S. C., being shown as Lot No. 12 on plat of Section 2 of North Gardens, made by Dalton & Neves, Engineers, January 1955, recorded in the RMC Office for Greenville County, S. C. in Plat Book EE, page 103, said lot fronting 80 feet along the West side of Azalea Court, running back to a depth of 160 feet on the South side, to a depth of 160 feet on the North side, and being 80 feet across the rear.
