C. on the northwest side of Nottingham Road and being known and designated as Lot No. 192 of Sherwood Forest as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "GG", at Pages 70 and 71 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Nottingham Road at the joint front corner of Lots Nos. 191 and 192 and running thence along the joint line of said Lots, N. 38-35 W. 197. 2 feet to an iron pin; thence N. 62-46 E. 70 feet to an iron pin; thence along the joint line of Lots Nos. 192 and 193, S. 43-31 E. 165. 3 feet to an iron pin; thence along Nottingham Road, S. 38-18 W. 85 feet to the point of beginning.
