Dollars, to be paid on or before 120 days from the date of the note which this mortgage secures, with power in the maker to anticipate and pay off any balance due hereunder at any time prior to maturity hereof without penalty.

with interest thereon from date of the said note at the rate of 5 1/2 per centum per annum, to be computed and paid quarterly until paid in full; all interest not paid when due to bear
