ALL that lot of land with the buildings and improvements thereon, situate on the South side of East Faris Road, in the City of Greenville, in Greenville County, S. C. being shown as Lot 20 and the Eastern one half of Lot 19 adjacent thereto of Block F, on plat of Kanatenah, made by J. E. Sirrine and Co., Engineers, August 25, 1923, recorded in the RMC Office for Greenville County, S. C. in Plat Book F, pages 130 and 131, and having according to said plat and a survey made by R. K. Campball July 26, 1958, the following metes and bounds, to wit:
