"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the west side of a surfaced road in the Mt. Lebanon Community about six miles northward from the City of Green, containing one acre, more or less, and having courses and distances according to survey for Ruth Farmer by J.Q. Bruce, Registered Surveyor, dated June 17, 1959, as follows, to-wit:

BEGINNING at an iron pin on the west side of said road, and running thence N. 86+00 W. 252.3 feet to iron pin; thence N. 24-51 W. 171.3 feet to an iron pin; thence S. 86-00 E. 335 feet to an iron pin on the west side of the road; thence along said road, S. 4-00 W. 150 feet to the beginning corner.
