NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

on the northeastern side of Vista Drive, near the City of Greenville, being shown as lot # 18, as shown on a plat of Section # 2, of Pine-Hurst, recorded in Plat Book MM at Page 153, and described as follows:

BEGINNING at an iron pin on the northeastern side of Vista Drive, at the corner of lot # 19, and running thence with the line of said lot, N. 36-30 E. 157.9 feet to iron pin; thence N. 53-30 W. 122.7 feet to iron pin; thence S. 24-32 W. 172.7 feet to iron pin on Vista Drive; thence with the northeastern side of Vista Drive, S. 53-30 E. 14.8 feet; thence with the curve of the turn-around, the chords of which are: S. 87-33 E. 43.9 feet, and S. 41-08 E. 34.9 feet to the beginning corner.
