SEND GREETINGS:

WHEREAS, I we the aforgoald mortgagor (s) in and by my/our certain promissory note, in writing, of even date with these presents am/arc well and truly indested to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of <u>Five Thousand, Seven Hundred and no/100</u> (\*5, 700, 00 —) Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said hote to be repaid with interest at the rate specified therein in installments of ....

Fifty Seven and no/100, 1... (\$ 57.00) ) Dollars upon the first day of onch and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently

extended, will be due and payable 12.7/12 years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or tailure to comply with any of the By-Laws, of said Association, or any of the stipulations of this mortgage, the whole amount due inder said note, shall, at the option of the hecome immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (19%) per centum attorney's fee beside all rosts and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or it said debt, or any part thereof, be collected by an attorney, or by legisl proceedings of any, kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more stully appear.

NOW.KNOW ALL MEN, That I/we, the said mortgagor(s) In consideration of the said debt and sum of money oforesaid, and for the better securing the payment thereof to the said PIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note and also in consideration of the further sum of Three Dollars to inclus the said mortgagor(s). plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book L,
at Page 188, and having, in the aggregate, the following metos and bounds, to-wit:

BEGINNING at an iron pin on the north side of county road at the corner of Lot No. 3, and counting thence along the line of that lot, N. 6-20 W. 293.4 feet to an iron pin; thence 8, 82-30 W. 240.8 feet to an iron pin in the center of the rear line of Lot No. 6; thence on a line across Lot No. 6, S. 2-30 E. 295 feet, more or less, to an iron pin in the center of the front line of said lot on the north side of the county road, which point is 140 feet cast of the intersection of Emma Street; thence along the north side of said county road, 258.8 feet to an iron pin at the beginning corner; being a portion of the same property conveyed to me by N.
