That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Oreenville, consisting of 1.34 acres, more or less, being on the Northwestern side of Old Georgia Road in Grove Township, as shown on a plat thereof made by John C. Smith, June 27, 1956, and having according to said plat the following metes and bounds:
