SEND GREETINGS:

VILIE, in the full and just sum of Four Thousand, Eight Hundred and No/100 - (\$ 4,800.00 ) Dollars for for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

extended, will be due and payable 10, years after date.
