NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagor, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagor, its successors and assigns,

All that place, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situated, lying and being on the Northern side of an unnamed street (now Ray Street) near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 45 as shown on a plat of P.L. Bruce Property, prepared by R. K. Campbell, Engineer, dated April, 1950, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book W at page 171, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northern side of an unnamed street (now Ray Street) at the joint front corner of Lots Nos. 44 and 45; and running thence with the line of Lot No. 44 N. 16 W. 98.5 feet to an iron pin in the subdivision property line; thence with the said subdivision property line S. 74-00 W. 70 feet to an iron pin at the joint rear corner of Lots Nos. 45 and 46; thence with the line of Lot No. 46 S. 16 E. 98.5 feet to an iron pin on the Northern side of Ray Street; thence with the Northern side of Ray Street N. 74-00 E. 70 feet to the point of beginning.
