NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and furthersums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Fairview Township,

South Carolina, about 3 miles West of Fountain Inn, being a portion of a larger tract of land conveyed to Sudie H. Peden by F. S. Peden by deed of September 16, 1941, recorded in Deed Book 237 at page 372. The property herein conveyed begins at iron pin on Southern side of paved road at corner of L. R. Peden Estate, running thence along that road South 55 East 494 feet to pin on lands of said Sudie H. Peden, thence along her lands South 20115 West 406 feet to corner on pine, thence North 68-15 West 165 feet to stake, thence North 48-07 West 404 feet to rock on L. R. Peden's Estate lands, thence along line of Peden lands North 30 East 381 feet to the beginning, and containing 4.9 acres and described on plat by J. R. Crawford, Surveyor, April 11, 1951, recorded in the R. M.C. Office for said County in Plat Book AA at page 41.
