MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

We, James A. Cooper and Betty V. Cooper, of Greenville County

SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAUNGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Sixteen Thousand, Five Hundred and no/100 (s. 16, 500, 00). Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

One Hundred Six and 32/100. (\$. 106, 32) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paide earlier and if not subsequently

extended, will be due and payable 25 years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days or failure to comply with any of the By-Laws of said Association, or any of the stibulations of this mortgage the whole amount due under said note, shall, at the option of the holder, become inmediately due, and apyable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorneys fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or it said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

BEGINNING at an iron pin on the eastern edge of Fairhaven Drive, joint front corner of Lots 60 and 61, and running thence along the joint line of said lots, N. 89-07 E. 185.7 feet to an iron pin on the line of Lot No. 219; thence along the line of that lot, N. 0-38 W. 136.8 feet to an iron pin on the southern edge of Hartsville Street; thence along the southern edge of Hartsville Street; S. 86-39 W. 147 feet to an iron pin; thence following the curvature of Hartsville Street as it interesects with Fairhaven Drive, the chord of which is S. 46-02 W. 36.9 feet to an iron pin on the eastern edge of Fairhaven Drive; thence along the eastern edge of Fairhaven Drive, S. 5-26 W. 106.8 feet to the beginning corner; being the same property conveyed to us by J.
