TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the Premises before mentioned unto the said WOODRUFF FEDERAL SAVINGS AND LOAN ASSOCIATION, its successors and assigns forever.

And we do hereby bind ourselves and our Heirs, Executors and Administrators to warrant and forever defend all and singular the said Premises unto the said WOODRUFF FEDERAL SAV-

INGS AND LOAN ASSOCIATION, its successors and assigns, from and against us and our '

Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming or to claim the same or any part thereof.

And we do hereby agree to insure the house and buildings now or hereafter erected on said lot in a sum not less than EIGHTY-TWO HUNDRED (\$ 8,200.00) Dollars fire insurance

and not less than EIGHTY-TWO HUNDRED (\$ 8,200.00) Dollars tornado insurance, in a company or companies acceptable to the mortgagee, and to keep same insured from loss or damage by fire or windstorm, and to hereby assign said policy or policies of insurance to the said mortgagee,

its successors and assigns; and in the event we should at any time fail to insure said premises, or pay the premiums thereon, then the said mortgagee, its successors and assigns, may cause the buildings to be insured

in some name, and reimburse itself for the premiums and expense of such insurance under this mortgage, with interest.

And we do hereby agree to pay all taxes and other public assessments against this property on or before the first day of January of each calendar year, and to exhibit the tax receipts at the offices of the WOOD-RUFF FEDERAL SAVINGS AND LOAN ASSOCIATION, immediately upon payment, until all amounts

due under this mortgage have been paid in full, and should 18 fail to pay said taxes and other governmental assessments, the mortgage may, at its option, pay same and charge the amount so paid to the mortgage debt, and collect same under this mortgage, with interest.

And it is hereby agreed as a part of the consideration for the low lierein secured, that the mortgagors shall
