NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Martgage at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, of hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township being known and designated as Lot No. 1, Section One, of Fenwick Heights as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "QQ", at Page 44 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Fenwick Lane at the joint front corner of Lots Nos. 1 and 2; and running thence along the line of Lot No. 2, N. 15-18 W. 283.6 feet to an iron pin; thence S. 49-29 W. 154.6 feet to an iron pin on the eastern side of Hunt's Bridge Road; thence along Hunt's Bridge Road, S. 12-34 E. 180.7 feet to an iron pin at the intersection of Hunt's Bridge Road and Fenwick Lane; thence around the corner of said intersection and following the curvature thereof, the chord being S. 56-39 E. 35.9 feet to an iron pin on the northern side of Fenwick Lane; thence along Fenwick Lane, N. 79-19 E. 125.0 feet to the beginning corner.
