I, Evelyn Hipp, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto LAURENS FEDERAL SAVINGS AND LOAN ASSOCIATION, LAURENS, S. C. (hereinafter referred to as Mortgagee); as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Fourteen Thousand, Nine Hundred, Fifty and No/100

DOLLARS (\$ 14, 950. 00), with interest thereon from date at the rate of six and one-half (6 1/2 %) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and furthersums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Dunklin Township, being Lot 6 on plat by Wm. F. Lee, Surveyor, September 13-19, 1918, and described as follows: BEGINNING at stake on new cut road leading Northeasterly to the Augusta Road; joint corner with Lot 7 and running thence with said road along line of the W. H. Smith property, South 43-50 West 9.58 chains to stake, 3x, thence South 12 East 10.40 chains to stake, joint corner with Lot 1, thence South 77-50 East 8.44 chains along line of said Lot 1 to stake, thence North 9-75 West 19-17 chains to the beginning; containing 11 acres, more or less.

This real estate was originally conveyed to the mortgagor and J. A. Hipp by deed of Annie L. Owens, September 30, 1946, and recorded in the Clerk's Office for said County in Deed Book 300 at page 444. The said J. A. Hipp conveyed his one-half undivided interest to the mortgagor by deed of May 17, 1961, and recorded in the R. M. C. Office for said County in Deed Book 674 at page 43.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner, it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
