All that lot of land in the county of Greenville, state of South Carolina, at the northeast corner of the intersection of Bon Air Street and Drury Lane, being known and designated as Lot No. 34 on plat of Glendale subdivision made by C. O. Riddle, May 1953 and recorded in plat book 22 pages 76 & 77 of the RMC Office for Greenville County, S. C.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
