NOW, KNOW ALL MEN, That I/we the said mortgagor(s) for and in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said mortgagee, according to the condition of the said note, and also in consideration of the further sum of THREE DOLLARS to me/us the said mortgagor(s) in land well and truly paid by the said mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and re leased, and by these presents do grant, bargain, sell and release unto the said STYLECRAFT HOMES CORPORATION its successors, and assigns, forever, the following described property, to-wit:

ALL that certain tract or parcel of land, together with all improvements thereon, situate, lying and being in Austin Township, Greenville County, South Carolina, containing one (1) acre, more or less, and being a portion of a 39.3 acre tract of land as shown on plat made by H. S. Brockman, Surveyor, on March 19, 1936, and being recorded in the Clerk's Office of Greenville County, South Chrolina, to which reference is hereby made for a more complete and accurate description, and being more particularly described as follows: \Beginning at an iron pin in the center of a public road leading to Cross Road Church as shown on said plat; thence running North 70° West for a width or distance of two hundred ten (210) feet along the center of a public road shown on said plat which also separates the lands herein from lands of Hugh Snow; thence running back in a Northerly direction between parallel lines for a depth or distance of two hurd red ten (210) feet to a rear width of two hundred ten (210) feet and being bounded as follows: West, North and East by other lands of E. G. Parker, et al; South by said public road which separates the lands herein from lands now or
