All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, buing known as the southeastern one-half of lot 35 on the plat of property of J.H. Roberts, recorded in plat book W at page 67, and being more fully shown on plat of Weldon & Bonnie Ruth Parr, recorded in the R.M.C.
