To All Whom These Presents May Concern: WOOTEN CORPORATION OF WILMINGTON

(herein called mortgagor), SENDS GREETING:

Dollars, in and by its certain promissory note in writing, of even date herewith, due and payable on or before 6 months from the date of this mortgage, the maker reserving the right to anticipate and pay off any balance due hereunder at any time prior to maturity without penalty therefor,

with interest from date of this mortgage, at the rate of Five and one-half (5 1/2%) percentum until paid; interest to be computed and paid Semi-Annually

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of its interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including ten per cent of the indebtedness as attorney's fee, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

Office for Greenville County, South Carolina in Plat Book "QQ" at Page 169, and having according to said plat the following metes and bounds to wit:

BEGINNING at an iron pin on the eastern side of French Lane joint front corner of Lots 110 and 111, and running thence N. 71-44 E. 129.5 feet to an iron pin, joint rear corner of Lots 110 and 111; thence N. 15-46 W. 72 feet to an iron pin, joint rear corner of Lots 111 and 112; thence S. 71-44 W. 131.2 feet to an iron pin on the eastern side of French Lane, joint front corner of Lots 111 and 112; thence S. 17-04 E. 72 feet along the eastern side of French Lane to an iron pin, the point of beginning.
