NOW, KNOW ALL MEN. That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being hythe State of South Carolina, County of Greenville, in Ganut Township, on the southern side of Hillcrest Drive (formerly known as Crest Hill Street) near the City of Greenville, being known and designated as Lots 9 and 10, Plat of property of C. O. Berry, by H. S. Brockman July, 1941, recorded in Plat Book M at page 29, and described as follows:

BEGINNING at a stake on the southern side of Hillcrest Drive 100 feet west from Berry Avenue at the corner of Lot 11 and running thence with the southern side of said Street, S. 89-50 W. 100 feet to a stake at the corner of Lot 8; thence with the line of said lot, S. 3-05 W. 165 feet to a stake at the corner of Lot 28; thence with the line of Lots 28 and 29, S. 88-15 E. 100 feet to a stake at the corner of Lot 11; thence with the line of said lot, N. 3-05 E. 168.5 feet to the Beginning.
