TO ALL WHOM THESE PRESENTS MAY CONCERN: Waymon W. Simpson

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Seven Thousand Five Hundred Seventy-Five and no/100-----

DOLLARS (\$7,575.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid in monthly instalments of Sixty-Five and no/100-----Dollars (\$ 65.00) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeastern side of Parker Road, and having, according to the plat of the property of J. E. Farr Estate, made by R. K. Campbell, July 25, 1961, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Parker Road, at the joint corner of the Farr property and property owned by Darnell, and running thence N. 56-0-E. 672.6 feet to old iron pin line of property owned by H. B. Cureton; thence with line of said property S. 43-26 E. 187.4 feet to old iron pin; thence with the line of property of Ruth Hunt Hayes S. 56-30 W. 702.5 feet to pin on Parker Road; thence with the northeastern side of Parker Road N. 34-22 W. 191.5 feet to the point of beginning.

Being the same property conveyed to the mortgagor by James F. Farr, et al. by deed to be recorded.
