"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known as the major portion of Let No. 2, of Section 2, of Timberlake subdivision, recorded in the R. M. C. office for Greenville County in Plat Book BB, at page 184, and having, according to a more recent survey prepared by C. O. Riddle, Engineer, April 4, 1961, entitled "Property of W. B. Mulligan" recorded in the R. M. C. office for Greenville County in Plat Book VV, at page 155, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northern side of the Qld Spartanburg Road at the joint front corner of Lots Nos. 2 and 23, and running thence with said Old Spartanburg Road, S. 78-25 W. 22.9 feet to an iron pin; thence continuing still with said road, S. 72-35 W. 89.1 feet to an iron pin in the intersection of Old Spartanburg Road and Timberlake Drive; thence with the curvature of said intersection, the chord of which is N. 49-52 W. 27.1 feet to an iron pin; thence with the eastern side of said Timberlake Drive, N. 7-40 E. 228 feet to an iron pin at the joint corner of Lots Nos. 1 and 2; thence along the line of Lot No. 1, S. 82-20 E. 101.2 feet to a point; thence along a new line through Lot No. 2, S. 0-07 W. 198.9 feet to the point of beginning; being the same property conveyed to us by W. B. Mulligan by deed dated May 22, 1961, and recorded in the R. M. C. office for Greenville County in Deed Vol. 677, page 302."
