All that certain place, parcel or lot of land with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Bates Township, in the Town of Marietta, being more particularly described as follows:

BEGINNING at a point 100 feet from Cleveland Avenue on the Tigerville Road and running thence along said road N. 77 1/3 E. 321 1/2 feet to an iron pin; thence S. 10 E. 107 1/2 feet to locust post; thence S. 81 3/4 W. 320 feet to an iron pin; thence N. 10 W. to the beginning corner.

Said premises being shown as Lot 5, Block 1, Page 517 of the County Block Book and also being the same conveyed to the mortgagors by deed recorded in Deed Book 488, at page 368.
