"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as the major portion of Lot No. 19 and a small portion of Lot No. 20 of a subdivision known as Dogwood Terrace as shown on a plat thereof prepared by J. Mac Richardson, R. L. S., dated May 1960, and recorded in the R. M. C. office for Greenville County in Plat Book UU, at page 5, and also beings known and designated as Lot No. 19 as shown on a revision of Lots Nos. 49, 20, and 21 of the Dogwood Terrace Subdivision according to a plat thereof prepared for Mauldin Construction Co. August 11, 1961 by C. C. Jones, C. E., and having, according to the latter plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the eastern side of Alpine Drive, joint front corner of Lots Nos. 18 and 19, and running thence with the joint line of said lots, N. 82-53 E. 210.8 feet to an iron pin; thence S. 4-21 E. 83.1 feet to an iron pin; thence S. 10-25 E. 100 feet to an iron pin; thence S. 78-57 W. 35 feet to an iron pin, joint rear corner of Lots Nos. 19 and 20; thence with the joint line of said lots, N. 47-16 W. 96 feet to an iron pin; thence continuing with the joint line of said lots, N. 82-38 W. 100 feet to an iron pin on the eastern side of Alpine Drive; thence with said drive, N. 2-35 E. 22 feet to an iron pin; thence continuing with said drive, N. 17-20 W. 39 feet to an iron pin; thence continuing with said drive, N. 33-25 W. 31.5 feet to the beginning corner; being the same conveyed to me by Mailidin Construction Co. by deed of even date, to be recorded herewith."
