WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even-date herewith, the terms of which are incorporated herein by reference in the sum of

Twenty-one Thousand -----

DOLLARS (\$ 21,000.00 ), with interest thereon from date at the rate of Five & one-half (5%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain piece, parcel or lot of land; with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Green on Crestview Circle, and being Lot No. 15 of BURGISS HILLS, INC., according to survey and plat by Piedmont Engineering Service, dated January 21, 1951, recorded in Plat Book "Y", pages 96-97, R.M.C. Office for Greenville County, and having the following courses and distances, to-wit:

BEGINNING at the rear corner of Lots Nos. 14 and 15 on the Taylor line, and running thence N. 33-34 E. 222.4 feet to an iron pin; thence S. 60-61 E. 55 feet to the corner of Lot No. 16; thence along the line of said lot, S. 1-29 194.5 feet to am iron pin on Crestview Circle; thence curving with said Circle, the chord of which is S. 27-56 W., 58 feet to the corner of Lot No. 14; thence N. 60-15 W. 135 feet to the beginning corner.

ALSO, all of that other certain parcel or lot of land adjoining that above described, being a portion of Lot No. 16 of BURGISS HILLS and having the following courses and distances, to-wit:

BEGINNING on an iron pin on the northern margin of Crestview Circle, joint front corner of Lots Nos. 15 and 16 on said plat, and runs thance with the common line of these lots, N. 1-29 E. 194.5 feet to an iron pin, back joint corner of said lots; thence S. 80-51 E. 11 feet to a stake, new corner; thence a new line - straight line - in a southerly direction about 192 feet to a stake on the northern margin of Crestview Circle, which stake is exactly 2 feet east from joint front corner of Lots Nos. 15 and 16 on said plat; thence with the margin of Crestview Circle 2 feet to the beginning corner.
