"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Bates Township, adjoining land now or formerly of Cleave Epps and B. H. Pierce, and having the following metes and bounds, to-wit:

REGINNING in the center of the Marietta Road, Cleave Epps corner and running thence, S, 52-00 W, 4.18 chains to an iron pin in the road; thence N. 25-00 W. 6.00 chains to an iron pin on branch; thence N. 52-00 E., 4.18 chains to an iron pin on Cleave Epps line; thence S. 25-00 E., 6.00 chains to the beginning corner, containing two and one-half acres (21), being all of the same conveyed to the mortgagor herein by deed of Jason B.
