All that piece, parcel or lot of land, with all improvements thermon, or hereafter constructed thereon, not into lying and being on the Southern side of Sullivan Street in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 2 as shown on a plat prepared by W.J. Riddle, Surveyor, dated November, 1950, entitled "Property of Nannie G. Morgan", and having according to said plat the following metes and bounds:

BEGINNING at an iron pin at the Southwestern corner of the intersection of Sullivan Street and a 10 foot alley, and running thence with the Western side of said alley S. 10-36 W. 137.1 feet to an iron pin; thence with the Northern side of said alley N. 85-15 W. 32 feet to an iron pin at the joint rear corner of Lots Nos. 1 and 2; thence with the line of Lot No. 1 N. 9-17 E. 135 feet to an iron pin on the Southern side of Sullivan Street; thence with the Southern side of Sullivan Street; thence with the Southern side of Sullivan Street S. 89-15 E. 40 feet to the point of beginning.
