WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on Bradley Boulevard in the City of Greenville, being designated as lot 47, 48 and a portion of lot 49 as shown on plat in University Park, recorded in Plat Book P at Page 27, and being more particularly described as follows:

BEGINNING at an iron pin on the southeast side of Bradley Boulevard at the joint front corner of lots 46 and 47 and running thence with line of lot 46, S. 37-34 E. 175 feet to iron pin on northwest side of a 20 foot alley; thence with said alley N. 56-26 E. 170 feet to iron pin in line with lot 49; thence into lot 49, N. 37-34 W. 175 feet to pin on Bradley Boulevard; thence with Bradley Boulevard S. 52-26 W. 170 feet to the point of beginning.
