with interest thereon from date at the rate of 7% per centum per annum, said principal and interest to be repaid: \$76.38 on the 29th day of December, 1961 and a like sum of \$76.38 to be paid monthly thereafter until paid in full, with interest at the rate of seven (7%) per cent, per annum, to be computed and paid annually in advance.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and re-leased, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon,

situate, lying and being in the State of South Carolina, County of Greenville, lying in Bates Township, on the southwestern side of Pleasant Retreat Church Road, containing 4.35 acres, and being more particularly shown on a plat of the property of David H. Poole, dated September 11, 1956, prepared by T. T. Dill and according to said plat being more particularly described as follows:

BEGINNING at a point at the center of the intersection of Pleasant Retreat Church Road with a farm road, joint corner of property of the mortgagor and property of David H. Poole, and running thence with the center line of said farm road S. 75-30 W. 691 feet to an iron pin in the line of property now or formerlyowned by H. Cruell; thence with the line of said property and the southwestern side of the above referred to farm road N. 33-45 W. 221.9 feet to an iron pin at the rear corner of property now or formerly of T.
