2. It is mutually agreed that the principal indebtedness including the readvance, is \$74954, and that it shall be paid in monthly installments of \$5155 each on the 18 day of each month hereafter, said payments to be applied first to interest, and then to principal until paid in full.

Obligor agrees that if a default will exist for a period of thirty (30) days in the failure to pay the principal indebtedness of any installment the eof or interest thereon or in the performance of any of the terms and conditions of the obligation as modified by this agreement, the Association may, at its option, declare the entire principal indebtedness with interest immediately due and payable and may proceed to collect same and avail itself of all rights and remedies given to it under the obligation in the event of a default.
4. All terms and conditions of the obligation shall continue in full force except as modified expressly by this agreement and the statute of limitations will not commence to run against the obligation until the expiration of the time for payment of the indebtedness as herein extended.
5. This agreement shall baid jointly and severally the heirs, the executors, the administrators, the successors, and the assigns of the Association and of the Obligor respectively.
