BEC INNING at a stake in the road which leads from the "Dug Hill Road to the Piedmont Council Boy Scout Camp Road on Lake Lanier, said stake being the common corner of the Jerry Drew, Lloyd Durham, and Floyd Blackwell tracts of land, and running thence with the Drew line South 89 Degrees West about 580 feet to an iron pin, Drew's corner; thence still with the Drew line North 25 Degrees West 253 feet to an iron pin, Drew's corner in the present Fisher line; thence with the dividing line between the property of Oscar Bjackwell and the property conveyed by this Deed North 63 1/2 Degrees kast 285 feet to a stake in the "Dug Hill" Road; thence with the said "Dug Hill" Road two calls as follows: South 67 1/2 Degrees East 50 feet; South 28 Degrees East 180 feet to the Intersection of fork of the Dug Hill Road and the road which leads from the same to the Boy Scout Camp mentioned above; thence with said last mentioned road four calls to the BEGINNING as follows: South 22 1/2 Degrees East 50 feet; South 11 1/2 Degrees East 197 feet, South 55 Degrees East 50 feet; South 11 1/2 Degrees East 155.5 feet to a stake in the road, the BEGINNING corner, containing four acres, more or less.
