WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our coloin promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF CHREEN'S

VILLE, in the full and just sum of Ten Thousand and No/100 ----- (4.10,000,00)

Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes as

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

extended, will be due and payable 20,.... years after date. The note further provides that if at any time any purition of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (80) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this morigage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's feat beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said tebt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the resents whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents (the resents gain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being known and designated as a portion of Lot No. 34 of the J. Rowley Yown property as shown on a plat thereof being recorded in the R. M. C. Office for Greenville County in Plat Book H at Page 51 and having according to a more recent survey prepared for Willie Owens and Mrs. Viola Owens by Ethan C. Allen, R. L. H. dated August 22, 1958 the following method and bounds, to-wit:

"BEGINNING at a point on the Northern side of Welcome Road, joint front corner Lots Nos. 33 and 34 and running thence with the joint line of said lots, N. 15-05 W. approximately 12-1/2 feet to an iron pin; thence continuing with the joint line of said lots, N. 15-05 W. 150 feet to an iron pin; thence S. 74-55 W. 80 feet to an iron pin; thence S. 15-05 E. 150 feet to an iron pin; thence continuing S. 15-05 M. approximately 12-1/2 feet to a point on the Northern side of Welcome Road; thence with said road, N. 74-55 E. 80 feet to the beginning corner; being the same property conveyed to me by Viola S. Owens by her deed dated June 7, 1961 and recorded in the R. M. G. Office for Greenville County in Deed Vol. 675, at Page 342."
