(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Four Hundred Twenty and no/100

DOLLARS (\$420.00), with interest thereon from date at the rate of six & one-half per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, shown as 1/2 acre, more or less, on plat of property of J. N. Hodgens, made by William A. Hudson, dated August 9, 1905, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at a point 9 23-30 W, 105 feet from the corner of the main tract of land, on the side of Renfrew Road, and running thence N 80 W, 210 feet to a point; thence S 21-30 W, 105 feet to a point; thence S 80 E, 210 feet to a point in the center line of Renfrew Road; thence with the center of the road, N 21-30 E, 105 feet to the point of beginning and being the same property conveyed to me in deed book 424 at page 111.

There is a mortgage executed by Charles H. Hodgens to Travelers Rest Federal Savings & Loan Association in the sum of \$6,000.00, dated October 8, 1960, recorded in mortgage book 838 at page 275. These two mortgages shall be of equal rank. A default under either mortgage will constitute a default under both mortgages.
